Resolutions

1. Receive and approve the audited accounts for the Year ended 31 December 2025 as published on the official documents page of the website of the club. (signed on the 20 March 2026)

Highlights: revenues 137k euro, deficit 72k euro cash balance 140k euro

2. Discharge the executive committee and the board for their management of the club for the year ended 31dec2025.



- 3. Approve the 2026 membership feesstructure: €500 renewal fee for the calendar year 2026 for all previous members plus €500 joining fee for new member joining in 2026. Partners of members can join or renew their membership at 50% which means €250 for 2026.**

- 4. Approve the calendar year 2027 membership fees: increase to 750 euro renewal fee plus 500 euro joining fee for new members. Partners of the members can join or renew their membership at 50% which means 375 euro for calendar year 2027. This will apply to all new sign ups for calendar 2027 that will occur in November and December 2026.**

- 5. Approve the revised reduced rent for the lease between Sir Stelios Haji-Ioannou as owner of the property that houses the Gustavia Yacht club in St barts from the current rent of 2500 euro per month to a reduced revises rent of 1000 euro per month with effect from 1Jan2027. The lease is an on going commitment that can be terminated by either party by giving the other one year's notice of termination. All common charges payable to the syndic of the co-propriete to be paid by the landlord.**
